

**NOTICE OF PUBLIC HEARING TO CONSIDER A MAJOR AMENDMENT TO THE  
CITY OF MADERA, CALIFORNIA, COMMUNITY DEVELOPMENT  
BLOCK GRANT FISCAL YEAR 2008/2009 ACTION PLAN**

Notice is hereby given that the City of Madera proposes to amend its Community Development Block Grant (CDBG) Fiscal Year 2008/2009 Action Plan in response to passage of the American Recovery and Reinvestment Act of 2009. The Act is expected to provide our community with a supplemental CDBG allocation in the amount of \$260,115 and the amendment is necessary in order for the City of Madera to receive these funds. The city has tentatively designated this additional funding for use in retrofitting public facilities with solar power and would appreciate input from residents regarding this option. The public hearing will be held Wednesday, June 3, 2009 at 6:00 p.m., in the Madera City Hall Council Chambers, 205 West Fourth Street, Madera, CA 93637.
